### **Condition of Acceptability:**

- 2. These fuses are intended for short circuit protection and overload protection only at levels not lower than the "Min Breaking Capacity." If low current overload protection is necessary below the "Min Breaking Capacity," then the application circuit should be provided with some other means for overload protection.
- 3. Time Current Calibration Performance at 135 and 200 percent of rated current has not been determined.
- 4. A Temperature Test should be performed in the end use equipment to establish max operating temperatures on the surfaces of the case. The Temperature Test should also be used to measure temperatures on the fuse body and terminals where internal wiring may contact. The temperatures at the terminations should comply with the requirements of the end use application product Standard.
- 5. The microswitch indicator device has not been investigated.
